#### INTRODUCTION

#### 1.1 Compliance

The "2019 Jordan Baja" rally will be run in compliance with:

- 2019 FIA International Sporting Code and its appendices (hereinafter the ISC)
- 2019 FIA Cross Country Rally General Prescriptions and it's appendices (hereinafter the GP)
- National Regulations, which comply with the FIA Regulations
- These Supplementary Regulations (hereinafter the SR)

Modifications, amendments and/or changes to these Supplementary Regulations will be announced only by numbered and dated Bulletins issued by the Organiser (and approved by the FIA) or the Stewards of the Meeting and approved by the ASN.

The Baja will be twinned with the Royal Motorcycle Club of Jordan Cup for Baja Rallies competition (hereinafter the RMCJ-BR). Therefore, the required interval of 30 minutes will be observed. The conditions of the motorcycle competition are set out in separate Supplementary Regulations.

A national Baja will run behind the Jordan Baja with a 20 minutes gap minimum from the last car.

Unless specifically covered within these Supplementary Regulations, the text of the 2019 FIA Cross Country Rally General Prescriptions (GP) applies and should be referred to.

Additional information will be published in the Rally Guide, issued on August 18<sup>th</sup>, 2019.

#### 5.2 Entry Procedure

Entries must be made using the online form available on the website <u>www.jordanbaja.com</u>.

Anyone wishing to take part in the Event must send the entry form, duly completed, to the secretariat of the event no later than the schedule mentioned in article 5.1 above along with the entry fee, accompanied by at least:



- The full name of driver & co-driver, their nationality and their addresses;
- Competition license number and driving license number of each member of the crew (copy required);
- The characteristics of the vehicle, group and class;
- The FIA Technical Passport number (TT-XX-XXX);
- The FIA Homologation Form number for T2 vehicles;
- ASN permission to take part in the event (copy required);
- Driver & Co-Driver passports or identification (copy required);

If the first driver is not the entrant, then a copy of the entrant's licence must be submitted with the entry form (Article 10.1 FIA Cross Country General Prescriptions 2019).

An electronic entry application (Internet) may be accepted. If the application is sent by fax, by email or made electronically, the original duly signed entry form must be presented during the Administrative Checks. A copy of the valid competitor's licence must accompany the entry form.

An entry application will be accepted only if accompanied by the total entry fees or by a receipt issued by the competitor's ASN. Entrants other than the first or second driver must hold an appropriate Entrants Licence issued by their ASN. A copy of the Entrant licence must accompany the entry form.

#### 5.3 Number of Entrants accepted

The maximum number of entrants will be "80". If more than the maximum number of entries is received, the acceptance of entries among the non-priority drivers will be at the sole discretion of the Organiser.

#### 5.4 Accepted Classes

The event is open to vehicles of a maximum gross weight of up to 3,500 kg for Groups T1 four or twowheel drive, T2 and T3 in due possession of a registration certificate. Vehicles, complying with the 'Score' regulations, will be accepted in the competition as per Article 8 (General Prescriptions). These vehicles must comply with the safety specifications laid down by the International Convention on Road Traffic, as well as the safety specifications laid down by the FIA regulations and by these regulations. The vehicles shall be assigned to the following categories:

- Group T1 Prototype Cross Country Vehicles:
- Class T1.1: T1 4x4 Petrol
- Class T1.2: T1 4x4 Diesel
- Class T1.3: T1 4x2 Petrol
- Class T1.4: T1 4x2 Diesel
- Group T2 Series Production Cross Country Vehicles:
  - o Class T2.1: T2 Petrol
  - o Class T2.2: T2 Diesel
- Group T3 Improved Cross-Country Vehicles Lightweight
  - Class T3.1: T3 P (Prototype)
  - Class T3.2: T3 S (Series)

• Fees mentioned includes the optional advertising, if a Competitor does not accept the optional advertising the entry fee will be increased by 25%.

#### 5.6 Service Area

Service Area is included in the entry fee, space allocated for each entrant is 150sqm (15x10m). If the entrant requires more space, he can purchase extra space in 50sqm (5x10) increments at 100€/50sqm (5x10m).

If two or more entrants share the same service area or if the entrant wish to add extra space, the organiser must be informed of this request no later than September 10<sup>th</sup>, 2019.


One "Service" plate will be provided to each entrant for free, extra plates are available with the following fees:

- "TRUCK" Plate:
- Vehicles over 3500kg
- These vehicles can enter the service area ONLY on Saturday 14<sup>th</sup> and Sunday 15<sup>th</sup> of September and must be parked there until the end of the event, on Saturday September 21<sup>st</sup>.
- "SERVICE" Plate:
- Vehicles less than 3,500 kg (van) used as service assistance.
- These vehicles can enter in the service area every day of the event.
- "AUXILIARY" Plate:
- Vehicles less than 3,500 kg for the transfer of the team staff.
- These vehicles can enter in the service area every day of the event.

All these vehicles must affix their plate on the top centre of the front windshield.

#### 6 INSURANCE

#### 6.1 Third Party Insurance:

The Entry Fee includes the insurance premium, which guarantees the Competitors cover for civil liability towards third parties (Public Liability). The indemnity provided under this insurance is the equivalent of 63000 € as total minimum liability cover. This insurance will commence from the beginning of the Rally until the end of the Event or up to the moment of permanent retirement, disqualification or exclusion. The insurance covers Competitors' cars on Special stages only.

#### 6.3 Exclusion:

The service, auxiliary & truck vehicles, even those bearing special plates issued by the Organisers, are not covered by the insurance policy of the rally; hence, their insurance policies remain the sole responsibility of the owner.

#### 6.4 Organisers Liability:

The Organisers decline liability for any accident caused to competitors and competing cars during the whole of the event, any in case of cataclysm, riots, demonstrations, vandalism etc. Competitors and crewmembers will have to sustain all consequences (damages, fines and penalties) created by any accidents. Organisers also decline any liability for breach of the Jordanian Laws and regulations.

#### 6.5 Additional Insurance:

In addition to the insurance covered by the Organiser, all Competitors are required to provide their own insurance covering all cars used in Jordan to cover civil liability towards third parties for the entire duration of their visit in the case of foreign crews, or permanent cover in the case of Jordanian residents. This is to cover competitors while they are on the road sections, or on public roads or highways.



#### 6.6 Proof of Insurance:

All Competitors must be able to present the insurance papers at the Administrative Checks. The burden of proof for a valid insurance rests solely on the competitor.

#### 6.7 In case of accident:

In the Rally itinerary, a competitor or his representative must notify in writing the Clerk of the Course, the Crew's Relations Officer or the Organiser as soon as possible.

#### Advertising and Identification

#### 7.1 Restrictions on Advertising

Competitors are allowed to affix any kind of advertising to their cars, if:

- It is authorised by the National Laws and the FIA Regulations.
- It is not likely to give offence.
- It is not political or religious in nature.
- It respects the regulations on competition numbers.
- It does not interfere with the crew's vision through the windows.

#### 7.2 National Restrictions on Advertising

- Tobacco: Advertising of tobacco, tobacco products and imitations, as well as smokers' requisites is forbidden according to the Jordanian legislation on cars, competition\service equipment and on the Team members' outfits.
- Alcohol: Advertising of alcoholic beverages is strongly restricted by law and not allowed on competing cars, service cars, equipment and clothes.

#### 7.3 Identification Numbers & Compulsory Advertising:

Competition Numbers, Rally Plates and Advertising will be provided by the Organiser and must be affixed as specified in accordance with Appendix 4 of these SR before Scrutineering.

#### 7.4 Number Plates:

In accordance with article 14.3 of the 2019 FIA Cross Country General Prescriptions.

#### 7.5 The text of the obligatory Organiser advertising is:

"2019 Jordan Baja".

#### 7.6 Optional Advertising:

Space may also be required for the Organiser's Optional Advertising. The text will be announced to Competitors in a Bulletin.

#### 7.7 Advertising:

Any advertising within this identification is obligatory and may not be refused by the competitors. No modifications are allowed to these panels.

#### 10.1 Location:

#### 10.2 Timetable:

The Administrative Checks will take place on Thursday, September 19<sup>th</sup>, 2019 between 09:00 and 13:00. The presence of both crew members is compulsory.

#### 11.1 Location:

#### 11.2 Timetable:

Thursday, September 19<sup>th</sup>, 2019 between 09:30 and 13:30.

#### 11.3 Vehicles Presentation:

Vehicles must be present at Scrutineering within 45 minutes following the Administrative Checks.

#### 11.4 Documents to be presented:

#### 11.5 Driver's equipment:

Helmets, head restraint (HANS) and flame-resistant clothing as well as other racing equipment will be checked at Scrutineering.

#### 11.6 Windscreen:

In case the windscreen is absent due to an accident, at the start of a Leg, the wearing of a full-face helmet with a visor or goggles of motocross type, or an open face helmet with motocross type of goggles is compulsory for all members of the crew, otherwise the vehicle will not be permitted to start the Leg.

#### 11.7 Safety equipment:

To only use the following Safety equipment supplied by the Organisers is compulsory, rental fees are included with Entry Fees:

- Tracking System.
- Vehicle to Vehicle Alarm System.

#### 11.8 Technical Changes

Please note that important technical changes have been implemented. Competitors need to pay particular attention to the following changes:

- Distance between Rollcage and helmet: Art. 283.8.3.2.5 of the 2019 Appendix J,
- Tinted Windows: Art. 283.11 of the 2019 Appendix J;
- Group T1 Minimum Weight: Article 8.7 of the 2019 FIA Cross Country Rally General Prescriptions;
- T3 Group (Engines Air restrictor): Art. 8.8 of the 2019 FIA Cross Country Rally General Prescriptions;
- Refuel Couplings: Art. 33.3 of the 2019 FIA Cross Country Rally General Prescriptions;
- TV Rights On-Board Cameras: Art. 49 of the 2019 FIA Cross Country Rally General Prescriptions;
- Survival Kit: Appendix III of the 2019 FIA Cross-Country Rally General Prescriptions."

#### 12 <u>Ceremonial Start</u>

#### 12.1 Jordan Baja Ceremonial Start

- 12.1.1 The Ceremonial Start will take place in Aqaba on Thursday, September 19<sup>th</sup>, 2019 at 19:00, it is mandatory to attend by all competitors.
- 12.1.2 A Holding Area will be setup on-site, Competitors MUST enter the Holding Area between 16:00 17:30.
- 12.1.3 No Timecards will be given, competitors will follow marshal's instructions.
- 12.1.4 A representative of the team may deliver the car to the Holding Area.



- 12.1.5 Competitors reporting late to the Ceremonial start will be penalized with 50 € per minute up to a maximum of 30 minutes. Thereafter, they will be reported to the Stewards who may apply penalties at their discretion.
- 12.1.6 The Holding area will be secured. Access is limited to Crew members and Media representatives carrying the appropriate identification \ accreditation.
- 12.1.7 The Ceremonial start will be in descending car number order, starting from the last competitor to the first.
- 12.1.8 Cars will start at one (1) minute interval. Then the cars will move back to Service Park.

### 13 <u>Start of the Baja</u>

#### 13.1 Publication of crews eligible to start and start lists

The Starting list for LEG 1 shall be posted on the Official Notice Board on Thursday September 19<sup>th</sup> at 15.00. The starting list for LEG 2, established according to Article 18 of the 2019 FIA CCR GP will be published according to the Program in these Regulations.

#### 13.2 Official start

The official start of the Baja will take place from Jordan Baja ceremonial start, Thursday September 19<sup>th</sup>, 2019 at 19:00.

#### 14 <u>Running of the Baja</u>

#### 14.1 Attention

Whilst the route generally avoids being in proximity of farms and inhabited areas, competitors are advised when driving in the vicinity their speed should be restricted. Crews must always take every precaution to minimize the nuisance and disturbance to all forms of livestock.

#### 14.2 Road Sections and Selective Sections

The itinerary of the Baja is made up of Road Sections with a scheduled time and roads open to traffic. The average altitude of the total distance of Selective Sections is 900 meters above sea level.

#### 14.3 Speed Control Zone

Penalty for exceeding Speed Control Zone speed is:

Between 1 & 15 km/h	1 minute	50 €
Between 16 & 40 km/h	2 minutes	100€
More than 40 km/h, 1 <sup>st</sup> impulsion	5 minutes	300 €
More than 40 km/h, 2 <sup>nd</sup> impulsion	10 minutes	500 €
More than 40 km/h, 3 <sup>rd</sup> impulsion	15 minutes	700€

#### 14.4 Withdrawal

Drivers who have withdrawn before the end of the rally or have ended the leg following roads other than those allowed, must notify the Clerk of the Course of their withdrawal maximum one-hour prior to



the publication of the start list of next LEG and must hand in their time card at the closest Control post. Competitors failing to abide to this prescription will be fined 100 €.

#### 14.5 Official time

The official time will be as GPS (Jordan time = GMT + 3).

#### 14.6 Safety, Navigation & Tracking Equipment

Anube Sport will provide the safety tracking services using a special device which will provide both tracking and navigation.

The device uses GPRS and Satellite (Iridium) communications, safety alerts, messaging and vehicle to vehicle functions.

For installation instructions see Appendix 3.

#### 14.7 "Vehicle to Vehicle Alarm System" (Article 26 of the FIA CCR GP 2019)

The tracking device (mentioned in Article 14.6) provides Vehicle to Vehicle Alarm System which complies Article 26 of the FIA CCR GP 2019.

Besides providing this functionality to the participants, the device records every related event between both participants, as reception, acceptance and rejections of overtaking requests

For further information refer to Appendix 3.

#### 14.8 Assistance in case of accident (Article 27 of the 2019 FIA CCR GP)

Complying with Article 27 of the FIA CCR GP 2019, the tracking device (mentioned in Article 14.6) can send breakdown and SOS alerts to Rally Control. Also, these alerts are communicated vehicle to vehicle to nearby participants. In addition, Rally Control can send questions to participant device.

See Appendix 3.

#### 14.9 Maximum Time allowed at the Time Controls

- A maximum lateness of **thirty (30) minutes** at every Time Control is authorized (including TC of final legs), this lateness will be penalized at a rate of 1 minute per minute or fraction of minute according the Art. 37.7 of the 2019 FIA CCR GP.
- The maximum time allowed as above may be modified at any moment by the Stewards, upon the proposal of the Clerk of the Course. Crews will be informed thereof as soon as possible.

#### 14.10TC exceeding Maximum time allowed

Any lateness exceeding **thirty (30) minutes** on the target time in a road section between two Time Controls will entail the application of a Fixed Penalty indicated in Art. 14.13.2

Such fixed penalty will be applied also in the case of lack of passage through one or more Time Controls, and will be added to other eventual penalties, including the fixed penalties of the Selective Section which has been done beyond the maximum time or not carried out.

The application of the fixed penalty for exceeding the maximum permitted lateness and/or for lack of TC may only be announced at the end of a LEG.

In order to benefit from the application of this Fixed Penalty crews must pass with their cars at the final TC of Leg 2 (TC 19), within the time schedule before the closing of control.



#### 14.11 Starting system for Selective Sections

The start signal will be done manually by the start marshal in accordance with Article 38.3 of the FIA CCGP 2019.

#### 14.12Maximum Time allowed in the Selective Sections

The Maximum Time allowed in the Selective Sections are:

The maximum time allowed above may be modified at any moment by the Stewards, upon the proposal of the Clerk of the Course. Crews will be informed thereof as soon as possible.

#### 14.13Fixed Penalties

The following penalties will be applied for Time Controls and Selective Sections not completed within the maximum time allowed.

14.13.1 Selective Sections: the following penalties will be applied for each Selective Section not performed/completed within the maximum time allowed:

Selective Section	Fixed Penalty
SS 1 "Salhiyah"	1 hour
SS 2 "Aqaba"	15 minutes
SS 3 "Qweirah"	1 hour
S.S. 5 "Wadi Rum"	1 hour

- 14.13.1.1 The fixed penalties mentioned above will be added to the maximum times of the Selective Sections concerned and to the other penalties set up.
- 14.13.2 Time Controls: the following penalties will be applied at these Time Controls if the competitor does not arrive or arrives after the maximum time allowed:

#### 14.14In order to be classified, the crew must:

14.14.1 Carry out at least one Selective Section in LEG 1 and one Selective Section in LEG 2.

14.14.2 Start the FIRST Selective Sections of LEG 1 & LEG 2





14.14.3 Check in at the Time Control at the end of LEG 2 before it's closing time.

# 15 Service Park / Refuelling

#### 15.1 Number and location

There will be 1 main Service Park & 1 Remote Service locations for the duration of the Baja.

- The Service Park is placed in Aqaba City Centre Aqaba (GPS: N 29° 32.070' E 34° 59.629').
- Remote Service is located in Wadi Rum (GPS: N 29° 40.340' E 35° 28.293').
- Service can be done only inside Service parks.

#### 15.2 Access times for service vehicles

 The service vehicles will be allowed to enter the Service Parks at the latest 1 hour before the entry time of the 1<sup>st</sup> car scheduled in the timing.

#### 15.3 Assistance between FIA competitors still in the race is permitted in all the Baja.

#### 15.4 Fuel/Refuel

- Their no limit on how much fuel a vehicle may carry.
- Only the crew may carry out the refuel procedure (Article 32 of the 2019 FIA CCR GP).
- In the Service Park it is forbidden to refuel.
- Refuelling is permitted only in the designated commercial fuel stations; using fuel on sale to the public. Only the crew may carry out this procedure
- The fuel stations authorized will be indicated in the Road Book with "FUEL STATION".

#### 15.5 General Regulations for Service

- 15.5.1 Service and repairs are permitted only if carried out in all the route (including the Selective Sections):
- By the crew of the concerned car
- By the crews of another entered vehicle still in the FIA race.
  - 15.5.2 In the service area, only three team personnel may work on a competing vehicle. They will be identified by a distinctive armband supplied by the organizer (Colour: Yellow) (Article 30.14 FIA CCR GP 2019).
  - 15.5.3 The "SERVICE" / "AUXILIARY" / "TRUCK" Plates must be affixed to the authorized vehicles. During the Baja, no vehicle will be permitted to enter the Service Park unless these plates are affixed. Inside the Service Park the staff charged by the Competitors must wear their wristband (Colour: White) supplied by the Organizers during administrative checks in a very visible way.



#### 15.6 Infractions of the Service and Refuelling rules - Penalties

All the infractions of the Service and Refuelling rules reported by the Judges of Fact or by other Officials will involve a penalty that will be decided by the Stewards of the Meeting and that can go as far as the disqualification from the race.

#### 15.7 Environmental Mat

Inside the service areas and the Parc Fermé at the end of LEG 1 and LEG 2 (Aqaba Service Park) competitors are obliged to lay under their cars a proper environmental mat to avoid the discharge of liquids on the soil. Otherwise, the Clerk of the Course will award a penalty of 150 € against the car's team (Article 30 of the 2019 FIA CCR GP).

#### 15.8 Garbage Bins

Inside the Service Park, there are bins for garbage. In case of not cleaning of the service area during and at the end of the race, the Clerk of the Course will award a penalty of 150 € to the competitor who has registered the car.

#### 16 TV RIGHTS - ON-BOARD CAMERA

Competitors wishing to carry an on-board camera must follow Article 49 of the of the 2019 FIA CCR GP.

Each competitor must:

- Send written request to info@jordanbaja.com
- Indicate number and position of all the on-board cameras;
- Provide all recordings at the end of each Leg;
- Pay a penalty of 500 € in case of not respecting the above rules.

#### 17 FINAL CHECKS AND PROTESTS

#### 17.1 Final Checks

- 17.1.1 The Final Checks will take place, according to the Program, Saturday September 21<sup>st</sup>, 2019 at 19.30, at the Service park.
- 17.1.2 Competitors who are selected for final Scrutineering (Stewards' decision) must provide proper equipment (including all sealed spare parts) and technicians at the final Scrutineering venue.
- 17.1.3 Each selected car will be driven to and from the final Scrutineering by a designated member of the team (who must be present at the finish) and accompanied by an Official.
- 17.1.4 In case of a protest, the protested car will be checked at the Service Park.

#### 17.2 Protest - Appeal

- 17.2.1 Protest deposit: The Protest deposit is fixed at: 1000€
- 17.2.2 National Appeal Deposit: The National Appeal deposit (JMS) is fixed at: 2000€ Only for National Event.
- 17.2.3 International Appeal deposit: The International Appeal deposit (FIA) is fixed at: 6000€

The vehicle must be presented at the technical checks with the installed stand, battery cable and antennas mounted for functional test.

#### 1) POWER CORD


Connect the red wire to the 12V (+) and black wire to the negative (GRD) pole of the battery. It must be connected directly to the battery (without interruption and no contact in the power supply). A 3A fuse (not included) must be installed on the red wire. Take the cable to the location to be installed the STELLA III.

2)BASE / SUPORTE

(Motorcycle and ATV) The bracket can

be mounted on the handlebars or on an iron plate near the navigation equipment. (cars and UTV) The stand can be mounted on the panel or in Santo Antonio.

The buttons of the STELLA III 3 must be visible and accessible by the competitor (pilot / navigator) even when seated buckled to the seat belt.



#### **IMPORTANT:**

Leave the cords (of the antennas and power) in place installed the base with at least 10 cm of clearance for easier handling.

Open space behind the stand at least 5 cm deep (lower right corner) for cordentry / connections.

#### ANTENNA: Iridium and radiofrequency

The Iridium antenna should be installed horizontally and unobstructed from obstacles towards the sky. It can be installed on the roof, hood or dashboard of cars and UTVs, and on fenders of motorcycles and ATVs. It is advisable to cover with adhesive tape (non-metallic when attached to metal surface) and "pull-up" (when attached to soft / plastic parts) for extra fixing.



The radio frequency antenna must be installed vertically in the roll bar (cars and UTVs) and cane / fork (motorcycles and ATVs). It is mandatory to use tabs (included in kit) to eliminate contact with metal and surrounding carbon fiber.

Once with the fixed antennas, take the SMA connectors to the base / stand where the STELLA III equipment will be installed.




